YEAR-ON-YEAR INFLATION RATES

Headline inflation rate or the annual rate of change on the prices of goods and services in the market basket for all income households in SOCCSKSARGEN Region rose to 7.0% in November 2022 from 6.6% the previous month. This is 1.0 percentage point lower than the national inflation of 8.0% for the current month under review. Inflation for the first nine months of the year averaged at 5.5%, mirroring the national average.

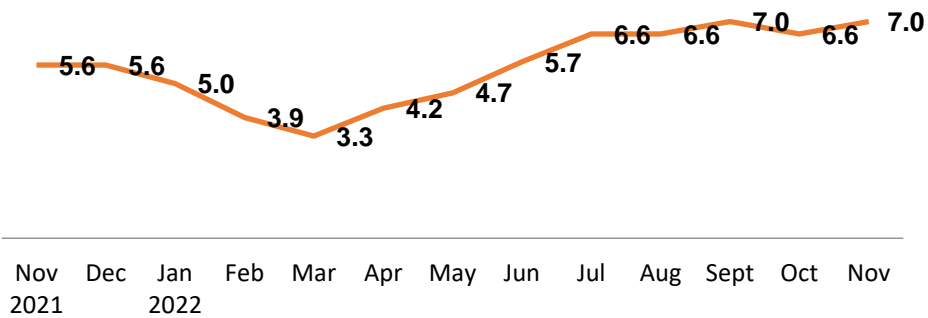
From 2019 to 2022, the annual average inflation rate on the prices of goods and services in the market basket was highest in 2022 at 5.5 percent. The lowest average inflation was in 2019 at 2.3 percent. The lowest monthly inflation was recorded in October 2019 at -0.3% while the highest was recorded in September 2022 and November 2022 at 7.0%. Headline Inflation for All Items in 2022 exhibited an uptrend from 3.9% in February to 7.0% in September and November surpassing the 6.6% recorded in July, August and September 2022 (Table 2).

Cotabato Province, with an inflation rate of 7.6%, was the highest contributor to SOCKSKSARGEN Region's 7.0% headline inflation in November 2022. It was followed by South Cotabato at 6.9%; General Santos City, 7.1%; Sultan Kudarat Province, 5.7%; Sarangani, 8.3%; and Cotabato City, 4.2%.

All of the provinces recorded higher price upticks in November 2022 when compared to the previous month. The highest increment was recorded in Sultan Kudarat at 0.8 percentage point.

From November 2021 to November 2022, the highest price uptick was noted in September 2022 and November 2022 at 7.0% while the lowest was recorded in March 2022 at 3.3%. Headline Inflation for All Items in November 2022 increased by 0.4 percentage point at 7.0% (Figure 1).

The major contributors to the uptrend of the November 2022 inflation were *Food and Non-Alcoholic Beverages* (from 7.8% to 8.9%); *Personal Care and Miscellaneous Goods and Services* (from 4.1 % and 4.4%); *Furnishings, Household Equipment and Routine Household Maintenance* (from 4.4% to 4.5%); and *Recreation, Sports and Culture* (from 4.1% to 4.3%).

On the other hand, commodity groups exhibiting lower price gains were *Transport* (from 11.8% to 11.2%); *Alcoholic Beverages and Tobacco* (from 10.7% to 10.5%); and *Housing, Water; Electricity, Gas and Other Fuels* (from 4.3% to 3.9%).

Meanwhile, six commodity groups had no change or negligible change from the previous month's rate: *Restaurant and Accommodation Services* (4.3%); *Clothing and Footwear* (4.1%); *Health* (2.7%); *Education Services* (1.1%); *Information and Communication* (1.1%); and *Financial Services* (0.0%) (Table 2).

The major contributors to the 7.0% inflation on the *Food and Non-Alcoholic Beverages (FNAB) index* in November 2022 were *Cereals and cereal products; Meat and other parts of slaughtered land animals; Sugar, confectionery and desserts; Fish and other seafood; and Vegetables, tubers, plantains, cooking bananas and pulses.*

Definition of Terms

Base Period/Year	this refers to the period, usually a year, at which the index number/points is set to 100. It is the point of index number series.
Headline Inflation	measures changes in the cost of living based on movements in the prices of a specified basket of major commodities. It refers to the annual rate of change or the year-on-year change in the Consumer Price Index.
Consumer Price Index	the average retail prices of a fixed basket of goods and services commonly purchased by households relative to a base year
Inflation Rate	the annual rate of change or year-on-year change in the CPI expressed in percent
Market Basket	refers to a sample of goods and services that are commonly purchased and bought by an average Filipino household
Weights	a system that considers the relevance of the components if the index
