



Headline Inflation in SOCCSKSARGEN Eases Further to 0.9% in September 2019



INFLATION

Headline inflation or the annual rate of change in the prices of goods and services in the market basket in SOCCSKSARGEN eased further to 0.9% in September 2019 from 1.5% in August 2019 (Figure 1).

INDEX POINTS

The Consumer Price Index (CPI) For All Items in SOCCSKSARGEN in September 2019 was recorded at 124.5 index points. This indicates that the average retail price of commodities that were included in the market basket for all goods and services for the month under review was higher by 24.5% compared to its prices in its 2012 reference base year. The September 2018 CPI for All Items at 123.4 was lower by 1.1 index points compared to its September 2019 index (Figure 2).






SEPTEMBER 2019 INFLATION RATE BY COMMODITY GROUP IN SOCCSKSARGEN REGION

Food and Non-Alcoholic Beverages (FNAB)

Inflation on FNAB slowed down further from -0.6% in August 2019 to -2.1% in September 2019 (Figure 3). Rice together with Bread and Cereals deflated in September 2019 both posting negative inflations for seven consecutive months. Fish, Vegetables, and Sugar, Jam, Honey, Chocolate and Confectionery also posted slower price increments while Meat sustained its August 2019 figure. Fruit is the lone commodity that posted faster price increment (Table 1).

Alcoholic Beverages and Tobacco (ABT)

At a faster pace of 14.2% in September 2019 from 10.7% in August 2019, ABT continued to post double digit gains (Figure 4). Tobacco recorded faster price increments and still stood in the double digit figure while Alcoholic Beverages sustained its August 2019 figure (Table 2).



CAF registered slightly slower price increments of 5.0% in September 2019 from 5.1% in August 2019 (Figure 5) as prices of Clothing slowed down from their July 2019 figure while Footwear sustains its figure (Table 3).


Housing, Water, Electricity, Gas and Other Fuels (HWEGOF)

Inflation rate for HWEGOF increased from 0.6% in August 2019 to 1.1% in September 2019 (Figure 6) as prices of Electricity, Gas and Other Fuels registered faster price increments although maintaining its negative figure in August 2019. Actual Rentals for Housing, Maintenance and Repair of the Dwelling, and Water Supply and Miscellaneous Services Related to the Dwelling all registered slower price increments (Table 4).



Furnishings, Household Equipment and Routine Maintenance of the House (FHERMH)

Prices for FHERMH decreased in September 2019 at 5.4% from 6.1% in August 2019 (*Figure 7*). Tools and Equipment for House and Garden, and Goods and Services for Routine Household Maintenance both posted slower price increments. Household Textiles and Household Appliances sustained their August 2019 figure while Furniture and Furnishings, Carpets and Other Floor Coverings and Glassware, Tableware and Household Utensils both registered faster price increments (*Table 5*).

Health


Prices of Health commodities and services registered a faster price mark-up from 4.1% in August 2019 to 4.3% in September 2019 (*Figure 8*). Prices of Out-patient Services and Hospital Services increased in September 2019 while prices of Medical Products, Appliances and Equipment slowed down (*Table 6*).








Slower annual price mark-downs for Transport were recorded in September 2019 at 0.7% from 1.2% last month (*Figure 9*) due to the further deceleration in prices of Operation of Personal Transport Equipment. Price of Transport Services on the other hand posted faster annual price mark-up this month under review (*Table 7*).

Communication

Continued slowdown in the price increments on Communication was noted from 0.8% in August 2019 to 0.6% in September 2019 (*Figure 10*) as Telephone and Telefax Equipment and Telephone and Telefax Services registered slower price increment from previous month. Postal Services sustained its previous month's figure (*Table 8*).








Recreation and Culture (RAC)

RAC prices slightly decreased from 1.8% in August 2019 to 1.7% this month under review *(Figure 11).* This was attributed in the drop in the prices of Other Recreational Items and Equipment, Gardens and Pets, and Newspapers, Books and Stationery. Other sub-commodities in this commodity group sustained their previous month's figure *(Table 9).*

Education


Education commodities and services sustained their figure at 7.3% in September 2019 from the same figure in the previous month (*Figure 12*). All education levels sustained their price paces during the month under review (*Table 10*).






Restaurant and Miscellaneous Goods and Services (RMGS)

RMGS recorded slower price increments at 4.2% in September 2019 from 4.5% in August 2019 (*Figure 13*). Price decrease on Catering Services, Personal Care as well as Personal Effects N.E.C. all registered price mark-downs during the month under review (*Table 11*).



Prices for all items in the market basket in September 2019 was lower than the previous month as lower price drop-offs were recorded in all its commodity group excluding ABT, HWEGOF and Health. The following were the changes in the figures of commodities who registered slower price mark-downs: FNAB (-0.6% to -2.1%), CAF (5.1% to 5.0%), FHERMH (6.1% to 5.4%), Transport (1.2% to 0.7%), Communication (0.8% to 0.6%), RAC (1.8% to 1.7%), and RMGS (4.5% to 4.2%). Three commodity groups registered faster mark-ups namely ABT (10.7% to 14.2%), HWEGOF (0.6% to 1.1%), and Health (4.1% to 4.3%). Education sustained its previous month's rate of 7.3% (*Table 12*).





PURCHASING POWER OF PESO (PPP)

The average Purchasing Power of Peso (PPP) in SOCCSKSARGEN in September 2019 was estimated at ₱0.80, sustaining the same figure from August 2019. This means that your ₱100.00 in September 2019 can only buy about 80.0% of the same basket of goods and services amounting to ₱100.00 in its 2012 reference base year. Note that the PPP in the region stood at ₱0.81 from January 2019 to June 2019 (*Figure 14*).

INFLATION RATE

During the past nine months, inflation rate for all income households in the region recorded a downtrend. From a high of 5.2% headline inflation in January 2019 to a price ease of 0.9% in September 2019 as prices of Food and Non-Alcoholic Beverages continue to fell *(Figure 15)*.

Definition of Terms	
Base Period/Year	this refers to the period, usually a year, at which the index number/points is set to 100. It is the point of the index number series
Consumer Price Index	it is defined as indicator of the change in the average retail prices of a fixed basket of goods and services commonly purchased by households relative to a base year
Inflation Rate	it is defined as the annual rate of change or the year- on-year change in the CPI expressed in percent
Market basket	is a term used to refer to a sample of goods and services that are commonly purchased and bought by an average Filipino household
Purchasing Power of Peso	is a measure of the real value of the peso in a given period relative to a chosen reference period. It shows how much the peso in the base period is worth in the current period. It is computed as the reciprocal of the CPI for the period under review multiplied by 100
Weights	a system that considers the relevance of the components of the index
