

Headline Inflation in SOCCSKSARGEN Eased at 3.1% in June 2020


INFLATION

Headline inflation or the annual rate of change in the prices of goods and services in the market basket in SOCCSKSARGEN eased at 3.1% in June 2020 from 3.6% in May 2020. Headline inflation for All Items exhibited an uptrend starting from 2.3% in January 2020 to May 2020 and slowed down in June 2020 (Figure 1).



INDEX POINTS


The Consumer Price Index (CPI) For All Items in SOCCSKSARGEN in June 2020 was recorded at 128.1 index points. This indicates that the average retail price of commodities that were included in the market basket for all goods and services for the month under review was higher by 28.1% compared to its prices in its 2012 reference base year. The June 2019 CPI for All Items at 124.2 was lower by 3.9 index points compared to its June 2020 index (Figure 2).

Food and Non-Alcoholic Beverages (FNAB)

FNAB declined to 2.3% in June 2020 from 3.4% in May 2020 (*Figure 3*) as inflation on Food groups decreased in June 2020 compared to the previous month. Prices of Meat, Fish, Fruit and Non-Alcoholic Beverages registered slower price mark-ups during the month under review. Vegetables prices also declined and exhibited deflation in June 2020. On the other hand, Bread and Cereals, Rice and Corn posted faster price upticks in June 2020. Sugar, Jam, Honey, Chocolate and Confectionery also recorded faster price mark-ups as it continued to post negative inflation (*Table 1*).





Alcoholic Beverages and Tobacco (ABT)

Sustained at 21.3% in June 2020 from the same figure in May 2020, ABT continued to post double digit gains since January 2020 (*Figure 4*). Alcoholic Beverages posted faster price mark-ups but Tobacco posted slower price mark-ups (*Table 2*).

Clothing and Footwear (CAF)

CAF posted slower price increments from 3.0% in May 2020 to 2.5% in June 2020 (Figure 5) as prices of both Clothing and Footwear registered slower price mark-ups from its previous month's figure (Table 3).






Housing, Water, Electricity, Gas and Other Fuels (HWEGOF)

Inflation rate for HWEGOF was sustained from 3.1% in May 2020 to the same figure in June 2020 (Figure 6) as prices of Actual Rentals for Housing remained the same during the month under review. On the other hand, Maintenance and Repair of the Dwelling and Electricity, Gas and Other Fuels registered higher price mark-ups while Water Supply and Miscellaneous Services Related to the Dwelling registered slower price mark-ups (Table 4).

Maintenance of the House (MOH)

MOH remained at the same level as the previous month with 4.5% in June 2020 from the same figure in May 2020 (*Figure 7*). The same levels during the first semester of the year. Furniture and Furnishings, Carpets and Other Floor Coverings, Household Textiles and Tools and Equipment for House and Garden posted faster price increments. On the other hand, Household Appliances, and Glassware, Tableware and Household Utensils registered slower price mark-ups. Goods and Services for Routine Household Maintenance sustained its previous month's figure (*Table 5*).






Health

Health commodities and services sustained its inflation rates of 2.8% in June 2020 from the same figure in May 2020 (*Figure 8*). Prices of Medical Products, Appliances and Equipment slowed down during the month under review while Out-patient Services and Hospital Services registered faster price mark-ups (*Table 6*).

Transport

Faster price mark-ups for Transport was recorded in June 2020 at a deflated figure of -2.1% from -4.6% in May 2020 (*Figure 9*). Prices of Operation of Personal Transport Equipment exhibited faster price upticks in June 2020 but remained deflated. Transport Services, on the other hand, exhibited deflation from its previous month's figure (*Table 7*).






Communication

Communication increased from its previous month's figure of 1.4% to 1.6% during the month under review (*Figure 10*) as Telephone and Telefax Services posted faster price increments. Postal Services and Telephone and Telefax Equipment sustained its previous month's figure (*Table 8*).

Recreation and Culture (RAC)

RAC registered slower price increments of 2.4% in June 2020 from 2.8% in May 2020 (*Figure 11*). Faster price increments were recorded in Audio-visual, Photographic and Information Processing Equipment and Newspapers, Books and Stationery. Meanwhile, Other Recreational Items and Equipment, Gardens and Pets registered slower price increments. Other Major Durables for Recreation and Culture and Recreational and Cultural Services sustained their previous month's figures (*Table 9*).






Education

Education commodities and services sustained a 7.3% price increment from January 2020 to May 2020 and eases to 0.2% in June 2020 (*Figure 12*). Services on all education levels recorded slower price mark-ups during the month under review (*Table 10*).




Restaurant and Miscellaneous Goods and Services (RMGS)

RMGS prices increased to 4.4% in June 2020 from 4.0% in May 2020 (*Figure 13*) as prices of Catering Services, Personal Care and Personal Effects N.E.C. registered faster price mark-ups during the month under review (*Table 11*).

Prices for all items in the market basket in June 2020 eased during the month under review as slower price mark-ups were recorded in FNAB (3.4% to 2.3%), CAF (3.0% to 2.5%), RAC (2.8% to 2.4%) and Education (7.3% to 0.2%). Faster inflation rates were recorded in Transport (-4.6% to -2.1%), Communication (1.4% to 1.6%) and RMGS (4.0% to 4.4%). On the other hand, commodities that sustained their previous month's rates were the following: ABT (21.3%), HWEGOF (3.1%), MOH (4.5%) and Health (2.8%) (Table 12).



PURCHASING POWER OF PESO

The average Purchasing Power of Peso (PPP) in SOCCSKSARGEN in June 2020 was estimated at ₱0.78. This means that your ₱100.00 in June 2020 can only buy about 78.0% of the same basket of goods and services amounting to ₱100.00 in its 2012 reference base year (Figure 14).

INFLATION RATE BY PROVINCE IN SOCCSKSARGEN REGION

Inflation rates in the provinces of SOCCSKSARGEN Region in June 2020 was highest in Cotabato province at 4.9%. It was followed by Sarangani and Sultan Kudarat both at 3.1%. The lowest was recorded in South Cotabato at 2.1%. A higher inflation rate was noted in Cotabato. On the other hand, slower price increments were noted in Sarangani, South Cotabato and Sultan Kudarat during the month under review (Table 13).
