## VOLUME AND VALUE OF IMPORTED AND EXPORTED GOODS, SOCCSKSARGEN REGION: JULY 2020

#### Merchandise Trade

SOCCSKSARGEN Region's export income in July 2020 went down by 31.2 percent at US\$70,293,351 from US\$102,105,334 in July 2019. The total volume of export commodities weighed 48,219,698 kilograms during the month under review from 93,164,127 kilograms in the same month of the previous year.

Import expenditures, at US\$70,241,834, went down by 5.2 percent from US\$74,107,578 in the same month of 2019. Imported goods reached a total of 185,706,092 kilograms from 108,038,527 kilograms in July 2019.

#### **Import Goods**

Skipjack or stripe-bellied bonito was the highest imported commodity in terms of Free-On-Board (FOB) value in SOCCSKSARGEN Region in July 2020 at US\$16,994,434 accounting for 24.2 percent of the total imports expenditures. *Yellowfin Tunas* followed at 13.4%, (US\$9,400,555); *Other flat-rolled products of iron or non-alloy steel,* (US\$4,339,151) at 6.2 percent; *Copra,* (US\$2,834,371) at 4.0 percent; and *Coal [briquettes, ovoids and similar solid fuels manufactured from coal],* (US\$2,709,461) at 3.9 percent;





Papua New Guinea was the region's biggest supplier of imported goods amounting to US\$18,168,877 in July 2020 accounting for 25.9% of the total import value of the region. China was second at US\$6,173,884 (9.6%); Japan at US\$6,279,828 (8.9%); Indonesia at US\$4,627,293 (6.6%); and South Korea at US\$4,485,671 (6.4%).

The top import goods from *Papua New Guinea* in terms of FOB value was *Skipjack or Stripe-bellied bonito*. From *China, Other prepared or preserved fish; caviar and caviar substitutes prepared from fish eggs; Japan, Other flat-rolled products of iron or non-alloy steel; Indonesia, Coal and similar solid fuels manufactured from coal; and South Korea, Skipjack or Stripe-bellied bonito.*



#### **Export Goods**

The top 5 export commodities in terms of FOB value comprised of *Tunas in airtight containers*, *Yellowfin tuna (include frozen and excludes fish fillets)*, *Pineapples*, *Other Fish Fillet and Other Fish*, *Meat* and *Fruit Juices [Other Concentrates]*. With a gross weight of 6,444,069.4 kilograms, export sales for *Tunas* was recorded at US\$21,188,483. It was followed by *Yellowfin Tunas* at US\$8,550,640; *Pineapples*, US\$8,488,922; *Other Fish Fillet and Other Fish Meat* at US\$7,480,057; and *Fruit Juices [Other Concentrates]* at US\$4,440,304.

Figure 3: Distribution of Top Five (5) Exported Commodities Based on FOB Value SOCCSKSARGEN Region: July 2020





The United States of America (USA) was the top destination of SOCCSKSARGEN Region's export commodities at US\$21,126,030 weighing 15,462,206.89 kilograms and with a share of 30.1% to the total export value of the region. It was followed by Japan at US\$11,835,127 (16.8%); Germany at US\$6,659,263 (9.5%); United Kingdom at US\$3,438,095 (4.9%); and Malaysia at US\$3,298,129 (4.7%).

The top commodities exported to USA include Yellowfin Tunas, Pineapples and Fruit Juices (other concentrates). In Japan, Other Fish fillets and other fish meat (whether or not minced), fresh, chilled or frozen; Germany, Tunas in airtight containers; United Kingdom, Tunas in airtight containers; and Malaysia, Palm Crude Oil.
