

YEAR-ON-YEAR INFLATION RATES

Headline inflation rate or the annual rate of change on the prices of goods and services in the market basket in Cotabato Province accelerate to 7.0 percent in July 2022 from 6.4 percent in June 2022. This is higher than the regional and national levels at 6.6 percent and 6.4 percent respectively. This is the highest inflation rate recorded this year. Inflation in July 2021 was lower at 5.4 percent. The average inflation for All items for the first seven months of the year stood at 4.6 percent. (Table 1 and Figure 1)

The acceleration in the Province inflation rate in July 2022 was mainly brought about by the higher annual increase growths in the index of food and non-alcoholic beverages at 6.4 percent; Housing, Water, Electricity, Gas and other Fuels at 6.7 percent and Clothing and Footwear at 2.9 percent. Also contributing to the uptrend in the overall inflation during the period were higher annual increments in the indices of the following commodity groups as compared with their previous month's inflation rates:

- a. Furnishing household equipment and routine household maintenance, 4.2 percent;
- b. Health, 1.1 percent;

On the contrary, the commodity that shows downtrend are the following:

- a. Alcoholic, Beverages and Tobacco, 9.1 percent ;
- b. Information and Communication, 1.7 percent
- c. Restaurant and Accommodation Services , 1.2 percent

The rest of the commodity groups retained their previous month's inflation rates or had zero percent annual growths. (Table 2).

For food index, it increased further by 1.0 percent, from previous month of 55 percent (June 2022) to 6.5 percent in July 2022.6.5 percent in July 2022,.

The annual growth rate of Sugar, confectionary and desserts index went up to 39.3 percent during the month, from 19.6 percent in the previous month. Meat and other parts of slaughtered land animals index also went up to 14.2 percent from 10.3 percent in the previous month. Milk, other dairy products and eggs index went up to 2.8 percent from 0.4 percent in the previous month. Corn went up to 13.0 percent from 6.6 percent in the previous month. Flour, Bread and other Bakery Products, Pasta Products and other Cereals (ND) index of 7.9 percent from 6.0 percent. Oils and Fats index went up to 17.9 percent from 13.9 percent. Ready–made food and other food products n.e.c index 6.1 percent from 5.3 percent in the previous month.

On the contrary, the food indices that were deflated are Rice 3.7 percent during the month from 4.1 percent from the previous month. Fish and other Seafoods 3.5 percent from 3.6 percent; Fruits and nuts (1.6) percent from (0.5) percent and Vegetable, tubers, plantains, cooking bananas and pulses 3.6 percent from 8.5 percent.

The following food groups exhibited a high annual increment during the month:

- a) Sugar, confectionary and desserts, 39.3 percent ;
- b) Meat and other parts of slaughtered land animals, 14.2 percent;
- c) Milk, other dairy products and eggs, 2.8 percent

Technical Notes

Headline Inflation Rate	refers to the rate of change in the CPI, a measure of the average price of a standard basket of goods and services consumed by a typical family.
Base Period/Year	this refers to the period, usually a year, at which the index number/points is set to 100. It is the point of the index number series.
Consumer Price Index	the average retail prices of a fixed basket of goods and services commonly purchased by households relative to a base year.
Inflation Rate	the annual rate of change or the year-on-year change in the CPI expressed in percent.
Market basket	refers to a sample of goods and services that are commonly purchased and bought by an average Filipino household.
