
• Year-on-year change of average CPI for the January to July, 2022 vs. 2021

YEAR-ON-YEAR INFLATION RATES

The headline inflation or the annual rate of change on the prices of goods and services in the market basket in General Santos for the month of July moved further to 7.7 percent. This is the highest inflation recorded this year, up by 1.3 percentage points from the previous month. The City's inflation rate is higher than the regional and national levels at 6.6 percent and 6.4 percent, respectively. With this month's inflation, its average inflation for All items from January to July 2022 stood at 6.0 percent. (Table D and Figure 1).

The main source in the upward trend of the City's inflation was the higher annual growth rate in the index of food and non-alcoholic beverages with 8.5 percent from 6.4 percent in June 2022, followed by transport with 25.8 percent from 21.2 percent and restaurants and accommodation services with 1.7 percent from 0.0 percent. Also contributing to the uptrend in the overall inflation during the period were higher annual increments in the indices of health, 1.4 percent and furnishings, household equipment and routine household maintenance, 2.4 percent.

On the other hand, the annual increase in the indices slowed down for clothing and footwear, 2.4 percent, housing, water, electricity, gas and other fuels, 6.3 percent, recreation, sport and culture, 1.6 percent and personal care, and miscellaneous good and services, 1.7 percent.

The rest of the commodity groups maintained their previous month's inflation rates (Table B).

Under food and non-alcoholic beverages group, meat, and others parts of slaughtered land animals (17.5%), fish and other seafood (9.2%) and cereals and cereal products (7.0%) are the top sources of acceleration of this group's inflation.

Food inflation increased further from 6.5 percent to 8.9 percent in July 2022. Food inflation was lower in July 2021 at 2.1 percent (Table C).

By Transport group, passenger transport by road (14.5%) was the top contributor to the acceleration in transport's inflation in July 2022. Fuels and lubricants for personal transport equipment with 51.4 percent inflation, passenger transport by road with 14.5 percent and passenger transport by air with 47.2 percent contributed to the month's inflation.

For restaurants and accommodation services group, restaurants, café and like (100.0%) mainly contributed to the July 2022 inflation.
