Inflation of SOCCSKSARGEN for the Bottom 30% Income Households Drops to 3.5% in October 2020

YEAR-ON-YEAR INFLATION RATES

SOCCSKSARGEN Region's Inflation Rate for the Bottom 30% Income Household fell by 3.5% in October 2020 from 3.6% in September of the same year. Among all commodity groups, only Food and Non-Alcoholic Beverages has recorded an increase in inflation at 1.2% from 0.3% in September 2020. Alcoholic Beverages and Tobacco and Transport has sustained a double digit record of 15.5% and 16.8%, respectively.

Slower inflation were noted in Clothing and Footwear (from 2.2% to 1.8%), Housing, Water, Electricity, Gas, and Other Fuels (from 3.8% to 3.1%), Furnishing, Household Equipment and Routine Maintenance of the House (from 1.1% to 1.0%), Health (from 4.3% to 3.9%) and Restaurant and Miscellaneous Goods and Services (from 4.6% to 4.4%). Little to no change in the month-on-month inflation were observed in Communication at 1.7%, Recreation and Culture at 0.1%, and Education at 0.3%.

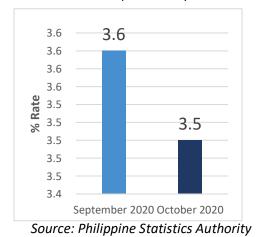

Food Products Not Elsewhere Classified (N.E.C.) recorded the highest annual price gains at 9.4%. Increase in price mark-ups from a deflation in the previous month were observed in the indices of Corn (from -0.1% to 1.0%) and Fish (from -5.0% to 1.4%). A deflation was recorded in Sugar, Jam, Honey, Chocolate and Confectionery (from 2.0% to -0.1%), while continued deflations were noted in Oils and Fats (from -1.8% to -1.5%) and Vegetables (from -4.6% to -1.2%).

Rice (from 0.9% to 0.1%), Other Cereals, Flour, Cereal Preparation, Bread, Pasta and Other Bakery Products (from 2.4% to 1.4%), Meat (from 3.1% to 2.3%), Milk, Cheese and Egg (from 0.7% to 0.6%) recorded declines in inflation rates.

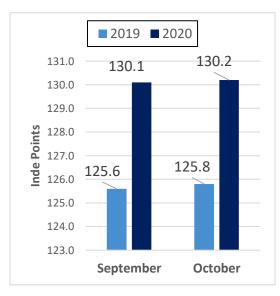

CONSUMER PRICE INDEX, OCTOBER 2020

The CPI for All Items for the Bottom 30% Income Households in SOCCSKSARGEN Region increased by 0.1 index point in October 2020 from 130.1 index points recorded in September of the same year. The average retail price of goods and services in the market basket increased by 30.2 percent from the 2012-based year. On the average, the same goods and services worth P100.00 in 2012 amounted to P130.2 in October 2020.

Among the 11 commodity groups in the market basket of the bottom 30% income households in SOCCSKSARGEN, Alcoholic Beverages and Tobacco (ABT) recorded the highest index point gains at 347.3. Tobacco posted the highest growth in index points at 428.8 among the sub-groups of ABT, while Alcoholic Beverages posted a reduction in index points from 163.5 in September 2020 to 163.1.
