Employment Rate in SOCCSKSARGEN Region hits 93.3 percent in July 2020 (Preliminary Estimates)

Labor Force Participation Rate slightly increased to 66.4%

In July 2020, the total population 15 years old and over in SOCCSKSARGEN Region reached 3.222 million, up by 2.1 percent compared to 3.156 million in July 2019. This number was about 4.4% of the national figures. Of the total population 15 years old and over in the region, more than half (66.4%) were in the labor force (Table 1).



The Labor Force Participation Rate (LFPR) or the proportion of employed and unemployed persons to the population 15 years old and over in the region was slightly higher by 1.1 percentage points compared to the same period the previous year. The region's LFPR was higher by 4.5 percentage points compared to the national estimates of 61.9%. Ten (10) regions had LFPR higher than the national average (*Figure 1*).

SOCCSKSARGEN Region was ranked 3rd among the 17 regions in the country with the highest LFPR. Northern Mindanao posted the highest at 68.8%. It was followed by CARAGA at 68.6%. The top two (2) regions with lowest LFPR were observed in Central Luzon at 58.9% and Central Visayas being the lowest at 57.8% (*Table 2*).



Employment Rate went down to 93.3%

About 93.3% of the working-age population who were in the labor force in SOCCSKSARGEN Region were employed in July 2020. This was 2.4 percentage points lower compared to the 95.6% posted in same period the previous year. The region's employment rate was 3.3 percentage points higher compared to the national average of 90.0% (*Figure 2*). SOCCSKSARGEN Region was ranked 6th in terms of employment rate. Twelve (12) regions had employment rates better than the national figures. BARMM posted the highest employment rate at 96.2% while the lowest was NCR with 84.2% (*Table 3*).

Unemployment Rate went up to 6.7%

At 6.7% in July 2020, unemployment rate in the region increased by 2.3 percentage points from 4.4% in July 2019. SOCCSKSARGEN Region's unemployment rate was lower by 3.3 percentage point compared to the national estimates of 10.0% in July 2020 (*Figure 3*). NCR had the highest unemployment rate at 15.8% followed by CALABARZON with 12.4%. Twelve (12) regions had unemployment rates lower than the national figure (*Table 4*).





Underemployment rate rose to 22.2%

Underemployed persons in the region rose to 22.2% in July 2020. About 5.3 percentage points higher compared to 16.9% the previous year. SOCCSKSARGEN region's underemployment rate was 4.9 percentage points higher compared to the 17.3% national average (*Figure 4*). The top 5 highest underemployed rates were recorded in MIMAROPA Region (27.2%) being the highest, followed by Northern Mindanao (24.1%), Bicol Region (23.3), SOCCSKSARGEN (22.2%) and CALABARZON (21.9%). In July 2020, only two (2) regions had single-digit underemployment rates with Davao Region at 9.2% and the lowest in BARMM at 9.0% (*Table 5*).



Percentage of the total number of persons in the labor force to the total population 15 years old and over.

Percentage of the total number of employed persons to the total number of persons in the labor force.

Percentage of the total number of unemployed persons to the total number of persons in the labor force.

Percentage of the total number of underemployed persons to the total number of employed persons.

Persons in the labor force who were reported either as at work (according to the definition of work), or with a job or business although not at work. Persons at work are those who did some work, even for an hour, during the reference period.

Persons are also considered employed if they are with a job/business even though not at work during the reference period because of reasons such as temporary illness/injury, vacation or other leave of absence, bad weather, or strike/labor dispute.

Employed persons who expressed the desire to have additional hours of work in their present job or in an additional job, or to have a new job with longer working hours.
