

# SOUTH COTABATO VITAL STATISTICS: 1<sup>ST</sup> QUARTER 2018

# **BIRTH STATISTICS**

The number of registered births in the province of South Cotabato for the 1<sup>st</sup> quarter of 2018 was 5,801 births. The figure showed a decrease of 8.36 percent compared to the 6,330 births for the occurrences for the quarter. Municipality of Santo Niño recorded the least number of recorded births with only 109 birth occurrences for the quarter.

# MARRIAGE STATISTICS

South Cotabato province recorded 1,489 marriages for the 1<sup>st</sup> quarter of 2018. An increase of 12.21 percent compared to the 1,327 for the 1<sup>st</sup> quarter of 2018. The municipality of Polomolok registered the highest marriage occurrences with 296 or 19.88 percent of the total marriages registered in the province. The least number of registered marriages is from the municipality of Lake Sebu with 2.62 percent or 39 marriages recorded for the 1<sup>st</sup> quarter.




Figure 2. Number of Births registered by City/Municipality: 1<sup>st</sup> Quarter of 2018

# **DEATH STATISTICS**

A total of 1,240 death occurrences for the province recorded for the 1<sup>st</sup> quarter. The figure indicated a slight decrease of 7.19 percent compared to the same quarter in 2017 with 1,336 death reported. Koronadal City registered the highest death occurrences with 510 deaths or 41.13 percent in the total deaths in the province. The municipality of Lake Sebu has the least number of registered deaths with 50 or 4.03 percent of the total deaths in the province.




Figure 3. Number of Births registered by City/Municipality: 1<sup>st</sup> Quarter of 2018

#### **TECHNICAL NOTES**

**Vital Statistics** are derived from information obtained at the time when the occurrences of vital events and their characteristics are inscribed in civil register.

Vital acts and events are the births, deaths, fetal deaths, marriages, and all events such that have something to do with an individual's entrance and departure from life together with the changes in civil status that may occur to a person during his lifetime. Recording of these events in the civil register is known as vital or civil registration and the resulting documents are called vital records.

**Live Birth** is a complete expulsion or extraction from its mother of a product of conception, irrespective of the duration of the pregnancy, which after such separation, breathes or shows any other evidence of life, such as beating of the heart, pulsation of the umbilical cord, or definite movement of voluntary muscles, whether or not the umbilical cord has been out or the placenta is attached; each product of such a birth is considered live born.

**Marriage** is a contract of permanent union between a man and woman entered into in accordance with law for the establishment of conjugal and family life.

**Death** refers to the permanent disappearance of all evidence of life at any time after live birth has taken place (postnatal cessation of vital function without capability of resuscitation).
