## PSA Cotabato participates in the Linang 2025: An In-Depth Conference on the Implementing Rules and Regulations (IRR) of RA 12009 (NGPA)

Hosted by the Philippine Institute of Certified Public Accountants (PICPA) - South Cotabato Chapter in collaboration with the Department of Budget and Management (DBM) Region XII, the Philippine Statistics Authority (PSA) - Cotabato with the leadership of its OIC-Chief Statistical Specialist, Norhayyah A. Tula actively participated in the Linang Conference 2025: An In-Depth Conference on the Implementing Rules and Regulations (IRR) of RA 12009 (NGPA), held on May 15-16, 2025 at the EMR Convention Center, Koronadal City.



This two-day conference brought together procurement officers, CPAs, BAC members, and local government officials from different provinces and regions to explore the newly published IRR of RA 12009, the New Government Procurement Act. This law, signed by President Ferdinand R. Marcos Jr. in July 2024, replaces the decades-old RA 9184 and modernizes the Philippines' procurement system to make it more transparent, participatory, and accountable procurement framework.

Delegates from PSA – Cotabato Province gained comprehensive updates and indepth discussion on the implementation of Republic Act No. 12009 also known as the New Government Procurement Act (NGPA) from the very knowledgeable and dynamic Regional Director of DBM Region XII, Akmad J.
